SPEAKING FEES

- 1. United States Speaking Fees—U to 4 hours, \$4,000 commissionable.**
- 2. United States Speaking Fees—Up to one full day, \$5,000 commissionable.**
- 3. Local Tampa & Orlando Markets Speaking Fees--Up to 4 hours, \$2,000 commissionable.**
- 4. Local Tampa & Orlando Markets Speaking Fees—Up to one full day, \$2,500 commissionable.**
- 5. Breakout Speaking Fee—Up to four hours, \$2,000 commissionable.**
- 6. Breakout Speaking Fee—Up to one full day, \$2,500 commissionable.**
- 7. Governmental Entities & Non-Profits--\$1,500 up to one hour, Tampa & Orlando market areas only.**
- 8. Terms of payment—when contract is signed, one half of professional fee is due and payable. It is non-refundable.**
- 9. At the arrival of John J. Alquist at the venue, the remainder of the fee is due and payable.**
- 10. Mr. Alquist's fees do not include travel expenses. These are billed in addition to his professional fees—including travel, hotel rooms, meals and local transportation (excluding incidentals). Client agrees to reimburse these expenses within 30 days.**
- 11. All payments are denominated in U.S. Dollars.**
- 12. We will consider barter arrangements in exchange for fees, using the clients retail prices and our fees defined herein.**
- 13. Mr. Alquist's performance cannot be filmed or recorded by the client without his written consent in advance.**
- 14. Mr. Alquist is permitted to sell his products after the presentation.**

CONSULTING FEES

- 1. United States fees--\$600 per day or \$75 per hour. \$600 project minimum.**
- 2. Tampa & Orlando Market Areas--\$400 per day or \$60 per hour. \$480 minimum.**
- 3. Business Plan Writing--\$75 per hour regardless of client location. \$300 minimum.**
- 4. Same general terms and conditions in speaker fee section apply to this section as well.**

WRITING FEES

- 1. Articles written for clients, \$75 per hour with a 4 hour minimum.**
- 2. Write HTML e-newsletters for clients at \$75 per hour with a 4 hour minimum.**
- 3. Same general terms and conditions in speaker fee section apply to this section as well.**

WELLNESS CONSULTING FEES

- 1. Telephonic wellness consulting. 45 minute consultations at \$50 each.**
- 2. Payment made in advance via PayPal on our website.**
